Planning and Advanced Reservation of Capacity (PARCA)

NOTICE: OPENING OF A PARCA EXIT WINDOW

9th March, 2018

Dear Industry Colleague,

In accordance with the Uniform Network Code, Section B, National Grid hereby publishes this notice to all interested industry parties that a PARCA Exit Window will be opened on Monday, 12th March 2018. The PARCA Exit Window provides an opportunity for those parties who are interested in applying for a PARCA to submit their applications during this time so that we can consider those applications alongside other potential projects.

The application received was as follows;

Phase 1

The geographical area of the project is North East Yorkshire & Lincolnshire (Region 3 in the Gas Ten Year Statement¹). This region is South of Bishop Auckland, north of Peterborough and Wisbech, and east of Nether Kellet and comprises NTS/DN exit zones NE1, NE2, EM1 and EM2.

The amount of NTS exit capacity applied for is between 30,300,000kWh/d & 33,400,000kWh/d.

The indicative capacity reservation date is 7th September, 2018.

The indicative capacity registration date is 1st January, 2021.

Phase 2

The amount of NTS exit capacity applied for is between 60,500,000kWh/d & 66,800,000kWh/d.

The indicative capacity registration date is 1st July, 2022.

Phase 3

The amount of NTS exit capacity applied for is between 121,000,000kWh/d & 133,600,000kWh/d.

The indicative capacity registration date is 1st July, 2023.

The PARCA Exit Window will be opened for a maximum of 40 consecutive business days from 12th March 2018, closing on 9th May 2018. If no further PARCA Applications are received within 20 consecutive business days the window will be closed on 10th April 2018.
