Planning and Advanced Reservation of Capacity Agreement (PARCA)

NOTICE: PARCA APPLICATION - RESERVATION OF NTS EXIT CAPACITY

4th January, 2018

Dear Industry Colleague,

In accordance with Uniform Network Code, Section B, National Grid hereby publishes this notice to all interested parties.

On 26th May, 2017 National Grid issued a notice with respect to the receipt of a competent Planning & Advanced Reservation of Capacity Agreement ("PARCA") application. The PARCA application was for National Transmission System ("NTS") exit capacity of between 58,241,267kWh/d and 71,183,770kWh/d in North East Yorkshire and Lincolnshire (Region 3 as defined in Gas Ten Year Statement¹). The indicative capacity Registration Date specified at the time was 30th November, 2020.

On 30th November, 2017 National Grid issued an informal notice ('Knottingley Power Station ExCS Informal Notice (including Exit Substitution & Baseline Revision') which outlined our proposals to meet the capacity requirement of 71,183,770kWh/d with an indicative capacity Registration Date of 30th November, 2020.

Today, 4th January, 2018, National Grid is issuing this notice to confirm the PARCA application has now progressed to Phase 2, and NTS exit capacity has been reserved as follows;
